I would like to first thank you for your interest in attending our Ward Melville Fishing Club Field trip to Blydenburgh State Park on May 14th, 2019 for some freshwater fishing. By signing the attached filed trip permission slip and returning it to the club advisor, you acknowledge the following:

- ✓ The duration of the trip runs from 200 pm until 5:30 pm
 - Transportation will be provided to BLYDENBURGH LAKE by the district's bus company.
 - The bus will depart from the school @ 210 PM sharp.
 - **ROUND TRIP TRANSPORTATION IS PROVIDED. Pick up must be made at Ward Melville High School.**
 - There is no cost for this trip but I can only take the first 30 who sign up!
 - Some tackle will be available for all students to utilize. (but there will not be enough for everyone. If you do not wish to share, you need to bring your own
 - We will be fresh water fishing for anything that is around. A good idea to bring a light weight spinning rod and any lures.
 - Students are encouraged to bring night crawlers. I will spend some time showing the students on the trip just how to secure their own while at the location. No real need to buy any bait for this trip.
 - Participants are encouraged to bring their own tackle with them
 - They should drop it off with Mr. Wilson in room 238 the morning of the trip...not a great idea to try and cram it into your locker or carry it along with you all day. Also, there is no need to have mom/dad/anyone else have to drive it up for you.

- ✓ Permission slips are due before we take our trip.
- ✓ Since this is a school related field trip, the Code of Conduct as outlined in the student handbook and also excerpted on the permission slip is in effect. All students are required to follow this code of conduct.
- ✓ Food and drink will not be provided. Due to the time of the trip it would be wise to pack a snack that can be carried in ones back pack.
- ✓ Students are encouraged to bring their own fishing equipment but are also responsible for their own equipment.
- ✓ Those students who do not have any equipment may share in the use of the club's equipment. Some bait will be caught (if possible) and provided for as well.
- ✓ Proper dress is an issue that must be addressed. ***It may be cold.*** Prepare for the weather in advance. Wear warm clothing. If it rains, we will get wet so have at the very least a poncho if the weather calls for rain. Students are recommended to wear sweatshirts and jeans as well as bring either waders or water proof boots. Remember, it is easy to remove a layer of clothing but you can't put on what you didn't bring.
